**RULES AND PROCEDURES FOR FARMERS**



Farmers/Vendors Rules and Procedures for the \$2.00 FreshConnect Checks Program:

1. FreshConnect Checks may be issued to Supplemental Nutrition Assistance Program (SNAP) customers, shopping with their Electronic Benefit Transaction (EBT) card, who purchase at least \$5.00 in tokens from the market. They are also issued to Veterans, Servicemembers and their immediate family members through regional Division of Veterans' Affairs offices on a first come, first serve basis.
2. FreshConnect Checks may be accepted at any operating farmers' market or farms stand in New York State where eligible food items are sold.
3. Eligible food items are based on the [SNAP eligible food items list](#) and include, but not limited to:
 

<ul style="list-style-type: none"> <li>• Breads &amp; Cereals</li> <li>• Fruits &amp; Vegetables</li> <li>• Meats, Fish &amp; Poultry</li> <li>• Honey</li> <li>• Coffee (whole beans and/or ground)</li> </ul>	<ul style="list-style-type: none"> <li>• Apple Cider</li> <li>• Dairy Products</li> <li>• Pasta</li> <li>• Baked Goods (for consumption at home)</li> <li>• Seeds/Plants (which produce food)</li> </ul>

4. FreshConnect Checks may be used in conjunction with other benefits including SNAP tokens, Health Bucks, and Farmers' Market Nutrition Program (FMNP) checks.
5. FreshConnect Checks should be stamped with an FMNP stamp for farmers participating in FMNP.
6. Vendors not participating in the FMNP, who sell a SNAP eligible food item, may participate in the FreshConnect Check Program.
  - a. These vendors should **sign or initial** the FreshConnect Checks when submitting them for reimbursement.
7. FreshConnect Checks may be submitted for reimbursement starting **February 1, 2020**.
8. FreshConnect Checks must be received for reimbursement no later than **January 15, 2021**.
9. FreshConnect Checks must be mailed to the Farmers Market Federation of NY; redemption is not through the bank.
  - a. Vendors need to complete and include a "Redemption Form" with each submission.
    - i. This information is required for reimbursement.
  - b. A reimbursement check will be mailed and may take up to 4 weeks for the vendor to receive.
