Quality and condition inspections of products each in quantities of 51 or more packages or when in tote containers:

- Over a half carlot equivalent of each product.....\$150
- Half carlot equivalent or less of each product\$125
- Inspections performed on submitted samples.....\$125
- For each additional lot of the same product\$25
- **For each 1/4 hour over 3 hours of waiting time caused by applicant.....\$17.50**
- Lots in excess of carlot equivalents will be charged carlot plus \$37.50 for each additional Full 1/4 carlot.
- Rate for billable mileage.....\$1.32

Condition only inspections of products each in quantities of 51 or more packages:

- Over a half carlot equivalent of each product.....\$125
- Half carlot equivalent or less of each product\$100
- For each additional lot of the same product\$25
- Rate for billable mileage.....\$1.32

Quality and condition and condition only inspections of products each in quantities of 50 or less packages:

- For each product\$100
- For each additional lot of any of the same product\$25
- Rate for billable mileage.....\$1.32

Other Services:

- Inspections performed on bulk loads of juice apples\$75

- Overtime Rate for all inspections performed, and travel time incurred outside the Grader’s regularly scheduled work week or work day (8:00AM to 4:30PM Monday thru Friday).....\$35/Hr.
- Saturday, Sunday, Holiday rate – regular fee plus \$35 per hour (minimum 4 hours per applicant) \$35 including travel – portal to portal
- PLI (for Dept. supplied tape or stickers) Tape charge \$.50 per pallet Sticker charge \$.05 each
- Consulting Service (including program formerly known as PQAP; and State Institution Inspections) – and hourly rate for non-carlot equivalent inspections such as count, size, temperature, container, digital imagery, etc. will be charged at a rate that reflects the cost of providing the service(hourly rate does not apply to travel time during Grader’s regularly scheduled hours).....\$70/HR.
- Rate for billable mileage.....\$1.32

Inspection Agreements:

- Inspections performed under 40 hour inspection agreements during the grader’s regularly scheduled work week (8:00 a.m. to 4:30 p.m. Monday thru Friday) (\$1,600 per 40 hour week for Shipping Point agreements and \$1,200 per 40 hour week for Quality Control agreements) plus mileage and expenses.

GAP Audits:

Billable Mileage will be to/from residence or nearest inspection office, whichever is less, and to include mileage and expenses between inspection sites.

***NOTE:** For hourly charges – charge in increments no smaller than ¼ hour.
