Applicant consents to free entry and will permit free access to the licensed premises, to the Commissioner, the Commissioner's agents and inspectors, in pursuance of the Commissioner's duty to supervise and regulate the dogs and cats, facilities, records, and other articles subject to the Commissioner's jurisdiction.
