Drafts when presented for payment must be accompanied by a certificate of the Commissioner of Agriculture and Markets of the State of New York signed as such stating the amount due, which has been determined by such Commissioner in accordance with the procedures set forth in Section 250-b of the Agriculture and Markets Law.
